



Responsibility Guidelines

- Main Entrance on corner of Black Mountain Drive and HWY 33 (Site 1)
 - **Equitable Charge is responsible for the faux rock, soft landscaping in front of sign and lighting only.**
 - City of Kelowna is responsible for sidewalk, mowing and tree maintenance.
 - Melcor is not responsible for any item.
- Entrance Feature along Black Mountain Drive between Begley Road and Black Mountain Crescent (Site 2)
 - **Equitable Charge is responsible for the signage, stonework, fencing and soft landscaping only.**
 - City of Kelowna is responsible for the sidewalks.
 - Melcor is not responsible for any item.
- Welcome Sign along Black Mountain Drive North of the Ascend Townhomes (Site 3)
 - **Equitable Charge is responsible for signage, stonework, soft landscaping, mowing and litter picking only.**
 - City of Kelowna is not responsible for any item.
 - Melcor is not responsible for any item.
- Fairways Sign on corner of Black Mountain Drive and Stockley Street (Site 4)
 - **Equitable Charge is responsible for the signage, stonework and any soft landscaping.**
 - City of Kelowna is responsible for mowing and litter picking.
 - Melcor is not responsible for any item.
- Trail between Stockley Street and Black Mountain Drive (Site 5)
 - **Equitable Charge is responsible for soft landscaping, stonework, weeding, litter picking and dog waste dispenser only.**
 - City of Kelowna is not responsible for any item.
 - Melcor is not responsible for any item.
- Landscaping on lower side of Stockley Street (Site 6)
 - **Equitable Charge is responsible for soft landscaping along the West side of lower Stockley Street only.**
 - City of Kelowna is responsible for the rockface on the East side of Stockley Street, sidewalks and street lighting.
 - Melcor is not responsible for any item.
- Uplands sign on Black Mountain Drive and Birkdale Ave (Site 7)
 - **Equitable Charge is responsible for signage, stonework and soft landscaping on the North and South side of road only.**
 - City of Kelowna is responsible for the rockface, drainage, sidewalks and street lights.
 - Melcor is responsible for marketing signage.

- Highlands sign on Carnoustie Drive (Site 8)
 - **Equitable Charge is responsible for the Highlands signage on the West side of Carnoustie Drive, the box planters on the West side of Carnoustie Drive, the Highlands signage on the East side of Carnoustie Drive, along with stonework and soft landscaping, box planters and memorial on the East side of Carnoustie Drive.**
 - City of Kelowna is responsible for the rockface, drainage, sidewalks and street lights.
 - Melcor is responsible for marketing signage on the Highlands signage on the West side of Carnoustie Drive.
 - Trail from Black Mountain Drive to Lochness Street (Site 9)
 - **Equitable Charge is responsible for bollard lighting only.**
 - **City of Kelowna is responsible for snow removal, landscaping and general maintenance.**
 - Melcor is not responsible for any item.
 - Trail descending from Site 9 Trail and ending at stairs at Henderson Drive (Site 10)
 - **Equitable Charge is responsible for bollard lighting, litter and general maintenance.**
 - City of Kelowna is responsible for the stairs from the trail to Henderson Drive.
 - Melcor is not responsible for any item.
 - Birkdale Park
 - **Equitable Charge is not responsible for any item.**
 - City of Kelowna is responsible for tennis courts, pathways, park equipment, furniture, lighting and landscaping.
 - Melcor is not responsible for any item.
 - Lund Park
 - **Equitable Charge is not responsible for any item.**
 - City of Kelowna is responsible for pathways, park equipment, furniture, lighting and landscaping.
 - Melcor is not responsible for any item.

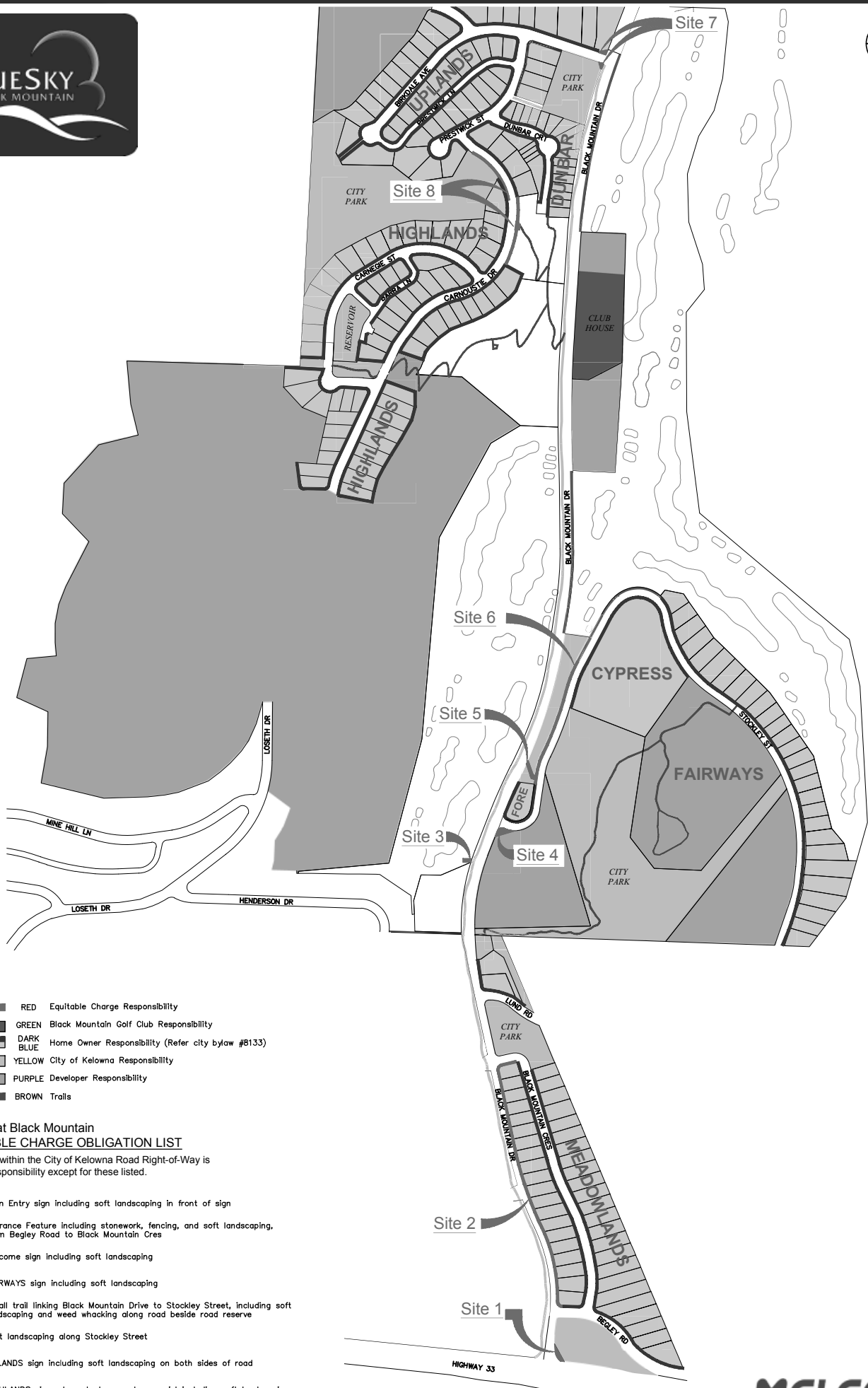

- Site 1 Main Entry sign including soft landscaping in front of sign
- Site 2 Entrance Feature including stonework, fencing, and soft landscaping, from Begley Road to Black Mountain Cres
- Site 3 Welcome sign including soft landscaping
- Site 4 FAIRWAYS sign including soft landscaping
- Site 5 Small trail linking Black Mountain Drive to Stockley Street, including soft landscaping and weed whacking along road beside road reserve
- Site 6 Soft landscaping along Stockley Street
- Site 7 UPLANDS sign including soft landscaping on both sides of road
- Site 8 HIGHLANDS signs, box planters, and memorial including soft landscaping
